- 3. Prior to placement on the Committee of Whole Agenda, the following must be submitted: a) resubmit plats in Eplan to ensure all conditions have been met, b) certificates, as listed in Section 16.20.020.
- 4. Conditions must be met and utility signatures are required on the plat prior to the City signatures.
- 5. No infrastructure improvements are permitted prior to the City Council approval of the final plat.
